Kindly note that paper, plastic confetti, and rice are not permitted on-site. However, we warmly welcome rose petals and dried florals to celebrate your special moment.





### TERMS & CONDITIONS p.1

The following Terms & Conditions relate to holding an event at Ondeen, 15 Onkaparinga Road, Verdun South Australia.

### **DURATION / ACCESS**

Venue hire duration for reception event is 6 hours – commencing at 5pm, concluding at 11pm. Venue hire duration for ceremony and reception event is 7 hours – commencing at 4pm, concluding at 11pm. Guests may arrive up to 30 minutes prior to this and have 30 minutes to leave the premises after the event concludes.

Vendors have access between 11am-3pm to set up on the date of the event (unless otherwise agreed) and between 11-12pm on the night of the event and 8am-10am the following morning to pack down the event and remove all hire equipment. All events are to conclude no later than 11pm.

Guest will have up to 30minutes to depart the property safely. In accordance with the Liquor Licensing & Council Regulations, the bar must close, and all music must cease at 11pm sharp for all functions held at Ondeen. Please note: Ondeen is not responsible for any loss or damage incurred for any property – hire or personal.

### **MINIMUM SPEND**

A minimum spend applies on all bookings. In the event minimum spend is not achieved, the balance between the minimum spend and the actual spend will be charged to your account as a venue fee. The minimum spend includes the cost of your hire fee, beverage package, additional items or upgrades, and the hiring of styling items. It does not include the cost of your security person, cocktails, spirits or additional staff. External vendors are also not included in the minimum spend.

### **SMOKING AND VAPING**

Ondeen is predominately a smoke free venue. All interior spaces at Ondeen, including the Verandah Deck are smoke free. There will be an allocated smoking area and Ondeen will specify its location.

#### **ENTERTAINMENT & MUSIC**

You may wish to have live music playing during canapés on the lawn or for the ceremony, and during your reception. All entertainers must follow the direction of Ondeen on the night. All music must cease at 11pm and may not exceed our decibel limit of 85 decibels. Management reserves the right to control the volume of entertainment at all times.

### **FOOD & CATERING**

All food served during an event at Ondeen must be prepared by Ondeen, with the exception of a cake. Strictly no BYO food, platters etc will be permitted. Cakeage is charged 7.50 per person includes cream and coulis plated.

### BYO

Strictly no BYO facilities available. Guests are not permitted to arrive at Ondeen with any alcoholic beverages. Any guests that bring alcohol onto the premises will be asked leave / or to dispose of them immediately.

### **TRANSPORT**

We highly recommend you consider the use of buses for your guests as we have limited parking for up to 35 cars. We prefer that cars are not left overnight in our car park, except in special circumstances. In this case your Event Manger will request the names and registration numbers of any owners leaving their vehicles at the conclusion of your event. All cars must be off premises by 11.30pm on conclusion of the event. No responsibility will be taken for vehicles left on the premises overnight.

We recommend medium to smaller coaches, no bigger than 40 seats.

### **SECURITY / CROWD CONTROL**

At any event held at Ondeen a registered security person is required for the duration of the event (eg. Reception 5-11pm) at the hosts own cost – this is not included in the event hire fee. Ondeen can organise the security person through a preferred company on your behalf. Please ensure you provide security with a vendor meal during your event.

#### **CLEANING**

Reasonable cleaning costs are included in the hire fee. You may be held responsible for any cleaning expense beyond normal wear and tear as well as any loss sustained by Ondeen. This may include (without limitation) damage to the venue or premises generally, its fittings, equipment or grounds whether caused directly or indirectly by you, your guests, invitees, outside contractors, or agents. No wax candles permitted.

All rubbish must be removed off premises at the conclusion of event. If rubbish is not removed, a cost of \$100-\$400 will be invoiced to you and must be paid within 7 days. On request rubbish can be removed the following day prior to 10am.

No confetti, glitter, table scatters, party poppers etc.

### **CONFIRMATION OF EVENT DETAILS**

Confirmation of all the event details must be confirmed by no later than 1 month prior to the event (this includes supplier contacts). Final guest RSVP numbers are due 2 weeks prior to your date. No refunds are available should there be a reduction in final numbers after the one-month period. If persons attending the event exceed invoice quantity, Ondeen reserves the right to invoice accordingly. This must be paid immediately by the Client. Please notify Ondeen if additional guests will be attending to ensure there is ample seating available. Ondeen caters for special dietary requirements such as vegetarian, vegan, coeliac, gluten-free, dairy-free.

### **FIRE SAFETY**

In the event of a 'Total Fire Ban' we require your bus company (if hired as transport of your guests) to stay on site at Ondeen for the duration of your event.

Smoking and the use of Sparklers is not allowed on the property during a 'Total Fire Ban' In the rare event of a catastrophic fire rating resulting in cancellation or evacuation of an event, Ondeen will assist in rescheduling your event. We observe a no wax candle policy.

### TERMS & CONDITIONS p.2

The following Terms & Conditions relate to holding an event at Ondeen, 15 Onkaparinga Road, Verdun South Australia.

### LIABILITY

The person named as Client shall be responsible in full for costs and charges as a result of the agreed booking. The Client shall be liable for any damage sustained to Ondeen by the Client and guests, agents for, or any other persons associated with the event, whether in the space allocated for the function or any other area of Ondeen.

Ondeen and its employees or agents will not be liable for any injury, damage or loss of any nature, however caused, suffered by the Client or guests, agents for or other persons associated with the function, whether before, during or after the function.

### **ADDITIONAL INFO**

All other items such as flowers, decorations and table settings are at the expense of the Client. Please speak to Ondeen should you require our recommendations or an experienced event stylist/planner to assist you in setting up the room for your event.

Please note that Ondeen is a on a working vineyard. Farming equipment and nets on vines may be visible at certain times of the year.

### FINAL ATTENDANCE NUMBERS

Final guest and supplier numbers are required 2 weeks prior to the event. No refunds are available should there be a reduction in final numbers after the one-month period. If persons attending the event or wedding exceed invoice quantity, Ondeen reserves the right to invoice accordingly. This must be paid immediately by the Client. Please notify Ondeen if additional guests will be attending to ensure there is ample seating available.

### RESPONSIBLE SERVICE OF ALCOHOL

Ondeen weddings & events are bound by the conditions of Liquor License Laws and has a duty of care for patrons and staff and we act accordingly. Staff are committed to the regulations of RSA (Responsible Service of Alcohol SA) and reserve the right to refuse the service of alcohol to any person. We will not serve any person alcohol less than 18 years of age and proof of age identification may be requested. We will not serve shots or spirits 'on the rocks.

### **BEVERAGE PACKAGES**

You must confirm beverage package selections 1 month prior to your event date. All beverages are the property of Ondeen and are not to be taken off the premises at conclusion of the event. Any beverages taken or consumed after 11pm will be invoiced at retail price directly. Vendors including, but not limited to; band members. (Catering staff, bar staff etc may not consume alcoholic beverages supplied by Ondeen unless included in the beverage package charge.)

Ondeen reserves the right to charge the relevant price per head for those that do not comply. The Sparkling wine option in the beverage package is limited at 2 serves per person. Eg. 100 guests = 200 serves provided. If you wish to purchase additional sparkling, it is \$50 per bottle. Sparkling wine price is subject to change. Please ensure you provide a security person with a vendor meal during your event.

### **BROKEN GLASSWARE**

If excessive glassware is broken (more than 5 glasses) each broken glass thereafter will incur a replacement fee of \$5 to the client.

### TENTATIVE BOOKING & CONFIRMATION WITH DEPOSIT

A tentative booking is held for a 7 day period under no obligation, after which time it will automatically cancel out. To confirm a tentative booking a signed copy of the The Ondeen Booking Application form with Terms and Conditions will be required. Payment of a non-refundable deposit of \$1000 will confirm & secure your booking. If deposit is not received within the 7 day terms your date will be immediately available to other clients.

### INVOICING

After securing your booking with a deposit, your event may be invoiced in 3 stages:

### 1. DEPOSIT INVOICE

A deposit of \$1000 for the date of your event is required to secure your event date. If deposit is not received within the 7 day terms your date will be immediately available to other clients.

#### 2. FULL PRE-PAYMENT

The outstanding balance of total estimated spend is required 4-6 weeks prior to the event along with a completed confirmation form, this may change depending on event date. This invoice is calculated on the estimated number of attendees for your event. Your Event Manager will contact you prior to this, to confirm your event details, so the final invoice can be issued. The total amount detailed on this final invoice is considered your minimum Event Value.

### 3. ADDITIONAL INVOICES

(After final issued) Guest numbers may increase, additional venue hire hours or spaces may be required etc... once we are notified you will be invoiced and this invoice is payable prior to the event.

### **PAYMENT ADVICE**

All invoice payments are to be made via bank transfer using the invoice number as the reference. All credit card (VISA/MC) payments incur a 2.7% admin fee.

Please email events@ondeen.com.au to arrange your payment schedule. Please note payments are required by the due date to ensure your event is confirmed.

### **CANCELLATIONS & PRICING**

Booking cancellations must be notified in writing, with deposits non-refundable and non-transferable.

If a cancellation occurs, the following terms apply:

- 6 Months or more prior to the event, the 1st invoice (Deposit) payment is forfeited.
- Between 6 months and the date of the event, all previous payments will be forfeited.

Please note that a surcharge of 20% will apply on public holidays and Friday, Saturday, Sunday adjacent to them. This surcharge applies to your total quote.

All prices within this package are correct at time of distribution and subject to change without notice.
