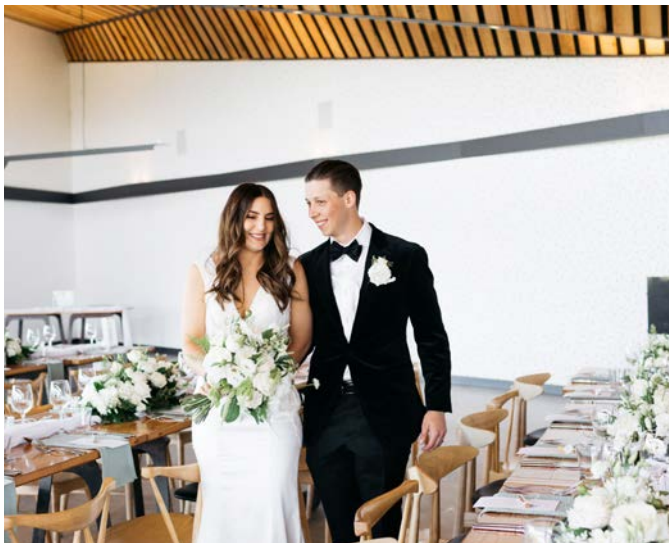

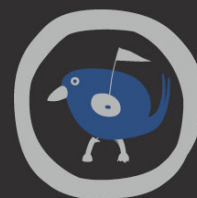

TERMS & CONDITIONS

We at Flying Brick are delighted you have chosen to host your upcoming wedding with us and we look forward to sharing in your special day.

The following terms and conditions form the agreement between the person(s) making the booking ("You" or "Your") and Flying Brick ABN 14 152 595 750 trading at 1251 Bellarine Highway, Wallington, 3222 ("Flying Brick"). This agreement commences when you make a booking with Flying Brick and payment of the initial deposit is received and Flying Brick confirms your booking in writing.

Please read these Terms and Conditions carefully prior to making Your booking and paying the initial deposit. If you need clarification with respect to any of these terms or conditions, we are only too happy to assist You.

OUR VINEYARD

Flying Brick is a working vineyard and at certain times of the year will have associated viticultural activities, which may include vine nets and farming equipment being present on the premises.

Flying Brick requests that You and Your guests, photographer and all other suppliers respect the workings of the premises.

EVENT DURATION & TIMINGS

Standard duration of a wedding reception package is 5 hours, unless otherwise approved by Flying Brick. Your event is to conclude no later than the agreed time. Guests will have 30 minutes to depart the property safely after the conclusion time as detailed on Your confirmation letter. In accordance with the Liquor Licensing Regulations, beverage service must conclude strictly at 11pm for all events held at Flying Brick.

ENTERTAINMENT & MUSIC

Should You wish to include entertainment/music at Your event, the additional cost and confirmation of this service is Your responsibility along with ensuring that Your supplier follow the following terms:

All entertainers must follow the direction of Your wedding coordinator or any Flying Brick Management present at Your event;

- All music must cease strictly by 11pm
- Has obtained any and all necessary permits, licenses or authorisations; and complies with any such permit, licence or authorisation;

Should the entertainment provided at Your event not comply with the above, You indemnify Flying Brick against any loss or damage caused directly or indirectly by the breach.

SUPPLIERS, SET UP & PACK DOWN

If You have extensive sound, lighting or styling requirements for Your wedding, you need to ensure the appropriate set up and pack down times have been allocated by Flying Brick and Your wedding coordinator. The standard set up time is from 4pm for Your event. If Your suppliers require additional set up time, this needs to be approved by Flying Brick prior to the day.

Any agreed access times will be advised by Your wedding coordinator prior to Your wedding day. At the end of Your event, Flying Brick staff will pack down all décor items including table flowers and store them at the venue. All items are required to be removed before 10am the following morning. It is Your responsibility to advise Your suppliers that we do not store items for any longer periods and that they are required to adhere to the advised times.

TERMS & CONDITIONS

DECORATIONS & SIGNAGE

Confetti, rice, glitter, balloons, dried rose petals, or any other similar items are not permitted at Flying Brick either outside or inside our premises. It is the responsibility of You to inform all guests in attendance prior to the event. If You or Your guests breach this clause You will be liable to pay for the cost of removing and cleaning as well as any other loss or damage caused as a result. Fresh rose petals are allowed.

Nothing is to be attached, pinned, nailed or glued to any wall, door or other surface in or on the Flying Brick property. All signage must be approved by Flying Brick prior to Your event to ensure no damage occurs to our grounds or premises. You are responsible for repairs and damages

GIFTS & PERSONAL PROPERTY

Flying Brick requires all gifts received and/or Your Wishing Well to be removed from the premises at the conclusion of Your event. Flying Brick takes no responsibility for damage or loss of gifts or any other property. You are solely responsible for all theft, loss or damage to any property, equipment, merchandise, gifts and personal items brought into Flying Brick by You, Your guests or any other persons attending Your event.

PARKING & TRANSPORT

Complimentary parking is available for guests on the car park grounds of Flying Brick. It is Your responsibility to ensure that You, Your guests and Your transportation suppliers park only in the designated areas and not to interfere with any marked entrances, exits or access points. Parking in the car park grounds is entirely at your risk and Flying Brick, its staff and contractors will not be liable for any damage caused to any vehicle however caused.

Flying Brick highly recommends You consider the use of buses for Your guests due to the regional destination of the property.

SMOKING

All indoor premises at Flying Brick are smoke free. There will be an allocated smoking area available for Your wedding, please see Your wedding coordinator for further details.

SECURITY

In accordance with company regulations and for the safety of you and your guests, security services are required for all evening events. Wedding receptions hosting up to 100 guests require one security guard, receptions with over 100 guests require an additional guard. Guards commence their service at 6.30pm and remain onsite until the last guest departs.

BYO & RESPONSIBLE SERVICE OF ALCOHOL

No beverages of any kind, including alcohol, are permitted to be brought onto the premises for consumption during, prior or after Your event by You or Your guests.

As an operator of a licensed venue, Flying Brick is required to meet certain obligations in relation to the responsible service of alcohol. Flying Brick has a responsibility to demonstrate best practice in terms of the service of alcohol and to set a positive example to customers and to other licensees by complying with and, where appropriate, exceeding mandatory compliance regulations. Flying Brick's staff are committed to the regulations of RSA (Responsible Service of Alcohol Victoria) and reserve the right to refuse the service of alcohol to any person. Alcohol will not be served to persons who are intoxicated or exhibiting signs of intoxication. Intoxicated persons will be requested to leave the property in a safe manner and will be assisted by the onsite security.

Flying Brick's staff endeavour to prevent underage drinking on the premises and proof of age identification may be requested.

RESPONSIBILITY OF GUESTS & CONDUCT

In consideration of Flying Brick hosting Your wedding event,

You agree that You must:

- Comply with and ensure all Your guests, suppliers, contractors, subcontractors and all other persons attending Your event comply with these terms and conditions and all Flying Brick regulations;
 - Access and use of Flying Brick premises in a safe and proper manner and that Your guests, suppliers, contractors, subcontractors and all other persons attending Your event do the same;
 - Ensure each of Your suppliers, contractors, subcontractors and all other relevant persons hold a current public liability insurance policy;
 - that each of Your guests, suppliers, contractors, subcontractors and all other relevant persons attending Your event promptly complies with any direction by any all Flying Brick staff
- Flying Brick may, at its absolute and unfettered discretion, suspend, terminate or control the event in any way if it believes that it is necessary to protect the venue or Flying Brick property from damage or to protect any persons from injury, risk or harm including where a person has breached these terms and conditions.

TERMS & CONDITIONS

Where an event is terminated by Flying Brick, Flying Brick will not be required to refund any amount paid by You in respect of the event and You will remain liable for any damage or loss suffered by Flying Brick.

NEW BOOKINGS

In order to book Your wedding at Flying Brick, You will need to complete and sign the form provided to You with these terms and conditions. Please note that Your booking is not confirmed until Flying Brick receive your initial deposit in cleared funds and confirms your booking in writing.

INITIAL DEPOSIT

Payment of a non-refundable/non-transferrable deposit of \$1,000.00 is required to confirm and secure Your wedding booking. This deposit will be applied to your wedding booking and contribute toward your payments received. When paying the initial deposit please ensure that You have returned a signed copy of these terms and conditions. Upon receiving the initial deposit and Your signed terms and condition, Flying Brick will forward You a confirmation letter and payment receipt.

FURTHER PAYMENTS

After securing Your wedding booking with a deposit, Your wedding will be invoiced in 2 further stages and tailored to Your wedding date:

A 50% deposit is due 3 months prior to Your wedding date.

The final payment will be on Your remaining balance and will be due 10 days prior to Your wedding together with Your signed event order. This invoice is calculated on all Your final detail as confirmed in Your event order, created by You and Your wedding coordinator.

Your deposit payment dates will be tailored to Your wedding and will appear in Your Dates to Diarise document for Your convenience.

Payments can be made via cash, EFTPOS, EFT transfer or credit card.

Regular payments i.e. monthly instalment payments are also welcomed. Please arrange this service with Your wedding coordinator at Flying Brick.

Please note payments are required by the due date to ensure Your booking is confirmed.

ADDITIONAL PAYMENTS (AFTER FINAL INVOICE ISSUED)

Please note Flying Brick will not invoice You post-event, payment is required before leaving the premises for any last minute charges that may incur. Guest numbers may increase in the final days prior Your wedding or you may add unexpected additions on upgrades, the costs of these will be added to Your account and required to be settled at the conclusion of Your event.

CANCELLATIONS

Should unfortunate circumstances force You to defer or cancel Your booking, Your subsequent payments will only be refunded under extenuating circumstances as deemed by Flying Brick Management. Under all other circumstances the deposit and subsequent payments are non-refundable and non-transferable. All cancellations must be made in writing to events@flyingbrickciderco.com.au

PRICING

Prices are confirmed in writing and every effort will be made to maintain prices as printed, however prices may be reviewed at Flying Brick's discretion, as a result of situation beyond the control of Flying Brick. You will be advised of any changes affecting the price

at least 30 days prior to Your event date.

Weddings booked on public holidays and will incur a 20% surcharge to all food and beverage costs.

Please note Flying Brick does not accept wedding bookings on Christmas Day or Good Friday. All quoted prices are inclusive of GST and prices are current at the time of printing and are subject to change without notice.

Final guest numbers (including suppliers receiving a meal) are to be provided by You 10 days prior to Your wedding. Flying Brick does not provide a refund if guest numbers decrease once numbers are finalized with Your wedding coordinator. Any additional guests added after this date will need to be discussed with Flying Brick.

INDEMNITY

You are liable for any damage sustained to Flying Brick, its staff, contractors, its premises, the contents of its premises and property owned or in the care of Flying Brick, You, Your guests, suppliers, contractors, subcontractors or any other persons attending Your event, including any failure by You or Your guests to observe any legislative regulatory, license or authorisation.

FORCE MAJEURE

Flying Brick's performance under these terms and conditions is subject to act of god, wars, government regulations or actions, terrorism, disaster, civil disorder, strike or other industrial dispute, curtailment of transport and any other emergency conditions which are beyond Flying Brick's reasonable control and which would render the performance of and this agreement by Flying Brick impossible or illegal ("Force Majeure Event"). Where Flying Brick's performance is impacted by a Force Majeure Event, Flying Brick may terminate this agreement by notice to You.
